Finance agreements for USD 533 million Tashkent Riverside project, including a 500 MWh Battery Energy Storage System (BESS), in Uzbekistan

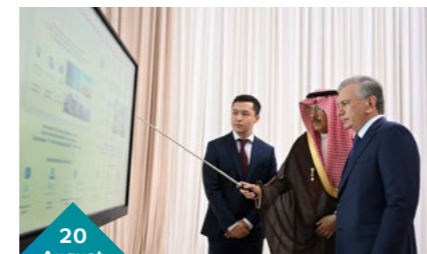

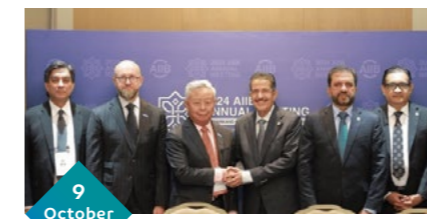

Agreement with the Uzbek Ministry of Energy for 2 GWh of standalone BESS capacity



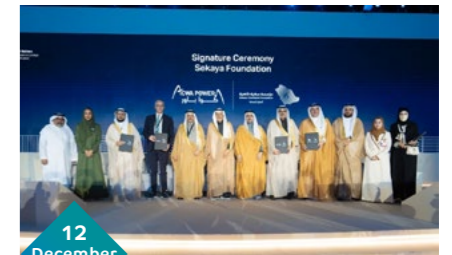
